## Definitions of Service Request Severity

To ensure that all service requests are reported in a standard format, Cisco has established severity definitions.

Severity 1 (S1) - Your network is down, or there is a critical impact to your business operations. You and Cisco will commit all necessary resources around the clock to resolve the situation.

Severity 2 (S2) - Operation of an existing network is severely degraded, or significant aspects of your business operation are negatively affected by inadequate performance of Cisco products. You and Cisco will commit full-time resources during normal business hours to resolve the situation.

Severity 3 (S3) - Operational performance of your network is impaired, but most business operations remain functional. You and Cisco will commit resources during normal business hours to restore service to satisfactory levels.

Severity 4 (S4) - You require information or assistance with Cisco product capabilities, installation, or configuration. There is little or no effect on your business operations.

# Chapter 1

## Introduction

---

### Overview

Cisco ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1) is a minor release for ICM/IPCC Enterprise & Hosted Editions, Release 7.0(0) that introduces [new features \(page 13\)](#).

### Baseline Requirements

ICM/IPCC Release 7.2(1) can be installed over ICM/IPCC 7.0(0), ICM/IPCC 7.0(0) SR1-SR4, ICM/IPCC 7.1(1), or ICM/IPCC 7.1(1) - 7.1(4).

If you are running any release earlier than Release 7.0(0), the components on which you want to install Release 7.2(1) on must first be upgraded to a Release 7.0(0) system. In addition, these components must meet the requirements of the [Cisco ICM/IPCC Enterprise & Hosted Editions Hardware and System Software Specifications \(Bill of Materials\)](http://www.cisco.com/en/US/products/sw/custcosw/ps1001/products_user_guide_list.html) (http://www.cisco.com/en/US/products/sw/custcosw/ps1001/products\_user\_guide\_list.html) for these releases.

It is important to note that the Campaign Manager for Outbound Option is not backwards compatible with older versions of the Dialer. The ICM/IPCC Release 7.2(1) Campaign Manager has the backward compatibility support for Dialers that are Release 7.0(0) SR4 ES56 and up and Dialers that are Release 7.1(3) and up.

For all other environments, the maintenance window must be extended to allow all components (server and desktops) to be upgraded at the same time.

A typical upgrade strategy is to upgrade the Central Controller components during one maintenance window, and then go back and upgrade PG's during later subsequent maintenance windows. With the Campaign Manager and Dialer not being backwards compatible, it prevents the use of that strategy.

A second upgrade strategy is to upgrade the "A" side of a solution during the first maintenance window, and then go back and upgrade the "B" side during a subsequent maintenance window. This does not work either for the following reasons:

1. The Campaign Manager is not redundant. When it is down, customers have no ability to do outbound campaigns.
2. Dialers are installed on both sides of the PG. There is no concept of an "Idle" dialer. When one side of a PG is taken down for an upgrade, you effectively lose 50% of their ability to perform Outbound campaigns.

The end result is that customers must upgrade all of the devices in their environment simultaneously. The maintenance window must be extended to accommodate the upgrading of all the devices.

## Release Strategy

Cisco ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1) is a *minor release*. A minor release is an incremental set of software fixes and a limited set of new functionality delivered in an automated installer. All published maintenance release content present at the point of the minor release ship date is contained within the minor release. The only exception is where a minor release development/testing schedule overlaps with that of a maintenance release. Engineering specials released prior to the code freeze date are also part of the minor release content.

  - Distributor Admin Workstation (AW) systems with CMS and/or the Agent Re-skilling Web Tool enabled
  - IPCC System Peripheral Gateway (PG) systems
  - WebView systems
  - CallManager Peripheral Gateway (PG) systems
  - System IPCC systems with the role of Administration and WebView Reporting.

- **Russian and Traditional Chinese localization**

Releases 7.2(1) continues to support and maintain previous localizations of Japanese, Simplified Chinese, Korean, European French, Canadian French, German, Spanish, Italian, Brazilian Portuguese, Dutch, Swedish, Danish, and now adds support and localizations for Russian and Traditional Chinese.

- **Chinese\_Taiwan\_Stroke\_BIN**
- **Cyrillic\_General\_BIN**

If a SQL 2000 Server is set with a collation beyond those defined above, ICM Setup and Logger displays an error message similar to “The SQL collation is not supported”.

To run localized ICM 7.2(1) correctly, customers must select correct SQL collation during SQL Server 2000 installation. The following table lists the combinations of the localized platform, SQL collation setting and localized ICM 7.2(1) environments.

## About the Release 7.2(1) Installer

### Release 7.2(1) Installer

As there are various ICM system configurations, ensure you have the appropriate installers for your combination of Release 7.2(1) core component software (ICM/IPCC Enterprise, ICM/IPCC Hosted, System IPCC) and desktop software (CTI OS Server, CTI OS Client, CAD) to match your specific system.

When launched, the new Release 7.2(1) Installer performs actions such as stopping services, file installations, the schema upgrade, and any necessary registry modifications. The Installer also automatically determines if the basic requirements are met to allow the installation to

continue. If a requirement is not met, the Installer corrects the problem if it can; otherwise it displays instructions so you can manually correct the problem, then it exits. As well as displaying the error on the screen, each component logs the error to its respective log file.

**Note:** System IPCC component roles are somewhat different from ICM/IPCC component roles. ICM/IPCC Distributor AWs with WebView and HDS have the role of *Administration & WebView Reporting* in System IPCC. An IPCC System PG plus CTI Server and CTI OS Server in System IPCC has the role of *Agent/IVR Controller*. The Outbound Option MR PG and Dialer have the role of *Outbound Controller*. In System IPCC, the Logger and CallRouter are always co-located on the same Central Controller machine.

Installations are usually performed during off-peak hours. Keep in mind that you might require more than one maintenance window. Normally, an initial maintenance window is established to get the ICM Central Controller and critical (key) AWs upgraded first. The remaining AWs and PGs are then scheduled as early as maintenance windows allow.

**Note:**

- Ensure you have run the Release 7.2(1) Installer on all your remaining AWs before bringing them online.
- The Peripheral Gateways do not necessarily have to be upgraded during the same maintenance window as the Central Controllers. For additional information, refer to the [Cisco ICM/IPCC Enterprise & Hosted Editions Hardware and System Software Specifications \(Bill of Materials\)](http://www.cisco.com/en/US/products/sw/custcosw/ps1001/products_user_guide_list.html) ([http://www.cisco.com/en/US/products/sw/custcosw/ps1001/products\\_user\\_guide\\_list.html](http://www.cisco.com/en/US/products/sw/custcosw/ps1001/products_user_guide_list.html)).

The Installer also performs uninstallation. You can perform either a *Permanent* uninstallation or a *Temporary* uninstallation.

**Note:** The option to perform a temporary uninstallation is available only on components having a database (the Loggers, HDSs, and Distributor AWs). Components that do not have a database can only be permanently uninstalled.

### Permanent Uninstallation

Selecting a *Permanent* uninstallation performs both a rollback of the database schema to the previous release schema and uninstalls the Release 7.2(1) application; deleting all configuration data specific to Release 7.2(1). New or changed configuration data that is unrelated to Release 7.2(1) features (for example, new agents and skill groups) is, however, retained.

A permanent uninstallation performs the following tasks:

- Performs the uninstallation of the Release 7.2(1) application.
- Reverts the database to the previous release of ICM/IPCC schema version.
- Logs the results, then exits.

## Temporary Uninstallation

Selecting a *Temporary* uninstallation uninstalls the Release 7.2(1) application, but does not perform a database rollback.

**Note:** If you choose the *Temporary* option, the Logger, AW, and HDS components cannot come online until Release 7.2(1) is reapplied. If you try to bring them online without reinstalling Release 7.2(1), an error is displayed indicating that there is a schema version mismatch.

The following are not uninstalled when either a *Temporary* uninstallation or a *Permanent* uninstallation is performed:

- the JRE/JDK version
- Support Tools

## Release 7.2(1) Installation/Uninstallation Overviews

The following sections provide an overview of an installation and an uninstallation of Cisco ICM/IPCC Enterprise & Hosted Edition, Release 7.2(1).

### Release 7.2(1) Installation Sequence

1. Bring the system to the [baseline \(page 11\)](#) requirements.
2. Perform a backup of both the side A and side B Logger and the HDS (Administration & WebView Reporting) databases using Microsoft SQL Server Enterprise Manager.
3. Disable configuration changes on both the side A and the side B Central Controllers.

How to disable configuration changes:

- a. Set the HKEY\_LOCAL\_MACHINE\Software\Cisco Systems, Inc.\ICM\*instancename*\RouterA\Router\CurrentVersion\Configuration\Global\DBMaintenance key to 1 on both sides of the CallRouter in the system being installed.

**Note:** RouterA in the registry key above is RouterB on the side B CallRouter.

- b. To verify, make a change and save. You should see this message:

*Failed to update the database. Exclusive access to the CallRouter denied because configuration changes are currently disabled in the router registry.*

4. Perform a backup of the configuration data from one of the sides using ICMDBA.

How to back up the Configuration Database using ICMDBA:

- a. Create a directory on a local drive. Ensure that the drive has enough available disk space to support the backup of your configuration database.

**Note:** Configuration databases can vary in size from one customer to another. The size ranges from a small configuration of about 15 MB to 150 MB on the larger side. If you are about to back up your configuration for the first time, and you are uncertain of the size of your configuration, plan for at least double the amount of the higher number on the drive where you want to store the backup. For example, plan for about 300 MB.

- b. Using Windows Explorer, navigate to the `icm\bin` directory to locate the **ICMDBA** executable. By default, the `icm\bin` directory resides on the system drive. The full path for the executable is `<ICM installed drive:\icm\bin`.
- c. Double-click **ICMDBA.exe**. The **ICMDBA** application window appears.
- d. Expand **Instances** to locate your Customer Instance.
- e. Drill down under your Customer Instance to the database.
- f. Select **Data > Export** from the menu bar. The Export data from window appears.

The default value in the Data type field is **Configuration**. The default Destination Path is `c:\`.

- g. Click **Browse** to navigate to the directory you created in the first step.
- h. Click **Export** when you are ready to begin the backup.
- i. Click **Start** in the application window. The export begins. An export completion message appears after successful export of data.
- j. Click **OK**, and exit **ICMDBA**.

**Note:** To verify the successful backup of the configuration data, open a Windows Explorer session. Navigate to the directory you created and verify whether the data files exist. The amount of space that the combined files use on your hard disk must accurately reflect the size of your ICM configuration.

**Note:** While you can start the installation on either side A or side B of a duplexed system, for the purposes of this document, it is assumed that side A is the first side to be installed.

5. Stop all side A Central Controller (CallRouter and Logger) services.
6. Run the [Release 7.2\(1\) Installer \(page 27\)](#) on the side A Central Controller.
7. Stop the services of the primary Distributor AW/HDS (Administration & WebView Reporting) associated with the side A Central Controller.
8. Run the [Release 7.2\(1\) Installer \(page 27\)](#) WebView Reporting).
9. To complete the installation process, reboot the side A Central Controller and the primary Distributor AW/HDS (Administration & WebView Reporting) associated with the side A Central Controller.
10. Stop all side B Central Controller (CallRouter and Logger) services. This causes default routing to occur.
11. Start the side A Central Controller and the primary Distributor AW/HDS (Administration & WebView Reporting) services associated with the side A Central Controller.
12. Verify side A operation.

**Note:** If side A is not operating properly, stop all side A services, return side B to service, and perform an uninstallation on side A. Resolve any issues encountered, then restart the installation process.

13. Run the [Release 7.2\(1\) Installer \(page 27\)](#) on the side B Central Controller.
14. Stop the services of the primary Distributor AW/HDS (Administration & WebView Reporting) associated with the side B Central Controller.
15. Run the [Release 7.2\(1\) Installer \(page 27\)](#) WebView Reporting).
16. To complete the installation process, reboot the side B Central Controller and the primary Distributor AW/HDS (Administration & WebView Reporting) associated with the side B Central Controller.
17. Start the side B Central Controller and Distributor AW/HDS (Administration & WebView Reporting) services associated with the side B Central Controller.
18. Enable configuration changes on both the side A Central Controller and the side B Central Controller.

How to enable configuration changes:

- a. Set the HKEY\_LOCAL\_MACHINE\Software\Cisco Systems, Inc.\ICM\

**Note:** RouterA in the registry key above is RouterB on the side B CallRouter.

- b. Verify that configuration changes are possible.
19. Verify side B operation.
  20. **Note:** The PG and CTI OS components must be upgraded to Release 7.2(1) in the same maintenance window. Running them mixed is not supported.

Perform the following:

- a. **Note:** Perform this action first.  
  
Stop the PG and CTI OS Server (Agent/IVR Controller) services and install ICM/IPCC Release 7.2(1) and CTI OS Release 7.2(1) on the PGs and CTI OS Servers (Agent/IVR Controllers), respectively.  
  
**Note:** The remaining actions can be performed in any order.
  - b. Stop all remaining Distributor AW/HDS (Administration & WebView Reporting) and Client AW services and install Release 7.2(1) on the remaining Distributor AW/HDSs and Client AWs.
  - c. Stop the CTI OS Desktop services and install CTI OS Release 7.2(1) on the CTI OS Desktops.  
  
**Note:** Agent/Supervisor Desktops need not be upgraded to 7.2(1) in the same maintenance window as the PG and CTI OS servers.
  - d. Stop the CAD Desktop services and install CAD Release 7.2(1) on the CAD desktops.
21. After the installation process has completed, and both the A and B sides of your system are operating properly, set the ICM/IPCC services that were changed from their original setting of **Automatic** to **Manual** for the installation, back to **Automatic** to ensure that the system functions properly after a reboot.

**Note:** If you are not sure which services were changed from **Automatic** to **Manual** during the installation of the Release 7.2(1), examine the setup logs located in C:\Temp\Minor Release ICM 7.2(1).

### Release 7.2(1) Permanent Uninstallation Sequence

1. Disable configuration changes on both the side A and the side B Central Controllers.

How to disable configuration changes:

- a. Set the HKEY\_LOCAL\_MACHINE\Software\Cisco Systems, Inc.\ICM\*instancename*\RouterA\Router\CurrentVersion\Configuration\Global\DBMaintenance key to 1 on both sides of the CallRouter in the system being installed.

**Note:** RouterA in the registry key above is RouterB on the side B CallRouter.

- b. Verify that configuration changes are prevented. The following message is displayed when attempting to save a configuration change:

*Failed to update the database. Exclusive access to the CallRouter denied because configuration changes are currently disabled in the router registry.*

2. Perform the following:

- a. **Note:** Perform this action first.

Stop the PG and CTI OS Server (Agent/IVR Controller) services and use the Add/Remove Programs tool to uninstall CTI OS Release 7.2(1) on the PGs and CTI OS (Agent/IVR Controller) Servers.

**Note:** The remaining actions can be performed in any order.

- b. Stop the CTI OS Desktop services and uninstall CTI OS Release 7.2(1) on the CTI OS desktops using the Add/Remove Programs tool.
- c. Stop the CAD Desktop services and uninstall CAD Release 7.2(1) on the CAD desktops with the Add/Remove Programs tool.
- d. Stop all remaining Distributor AW/HDS (Administration & Webview Reporting) and Client AW services and using the Add/Remove Programs tool, uninstall Release

- 7.2(1) from the remaining Distributor AW/HDSs (Administration & WebView Reporting) and Client AWs.
3. Stop the services on a Distributor AW/HDS (Administration & WebView Reporting) associated with the side A Central Controller.
  4. From the Add/Remove Programs tool, uninstall Release 7.2(1) on the Distributor AW/HDS (Administration & WebView Reporting) associated with the side A Central Controller using the [Release 7.2\(1\) Installer \(page 35\)](#).
  5. Stop all side A Central Controller (CallRouter and Logger) services.
  6. From the Add/Remove Programs tool, uninstall Release 7.2(1) on the side A Central Controller using the [Release 7.2\(1\) Installer \(page 35\)](#).
  7. After the uninstallation process has completed, reboot the side A Central Controller and the Distributor AW/HDS (Administration & WebView Reporting) associated with the side A Central Controller.
  8. Stop all side B Central Controller (CallRouter and Logger) services. This causes default routing to occur.
  9. Start the side A Central Controller and Distributor AW/HDS (Administration & WebView Reporting) services associated with the side A Central Controller.
  10. Verify side A is operational and is successful.
  11. Stop the services on a side B Distributor AW/HDS (Administration & WebView Reporting) associated with the side B Central Controller.
  12. From the Add/Remove Programs tool, uninstall Release 7.2(1) on the Distributor AW/HDS (Administration & WebView Reporting) associated with the side B Central Controller using the [Release 7.2\(1\) Installer \(page 35\)](#).
  13. From the Add/Remove Programs tool, uninstall Release 7.2(1) on the side B Central Controller using the [Release 7.2\(1\) Installer \(page 35\)](#).
  14. After the uninstallation process has completed, reboot the side B Central Controller and the Distributor AW/HDS (Administration & WebView Reporting) associated with the side B Central Controller.
  15. Start the side B Central Controller and the Distributor AW/HDS (Administration & WebView Reporting) associated with the side B Central Controller services.
  16. Verify side B is operational and is successful.
  17. Stop all remaining Distributor AW/HDS (Administration & WebView Reporting) and Client AW services and uninstall Release 7.2(1) on the remaining Distributor AW/HDSs and Client AWs using the Add/Remove Programs tool.
  18. Upon completion of the uninstallation, reboot and verify the operation of all remaining Distributor AW/HDS (Administration & WebView Reporting) and Client AW services.

19. Enable configuration changes on both the side A Central Controller and the side B Central Controller.

How to enable configuration changes:

- a. Set the HKEY\_LOCAL\_MACHINE\Software\Cisco Systems, Inc.\ICM\<instance name>\RouterA\Router\CurrentVersion\Configuration\Global\DBMaintenance key to 0 on the side A and side B CallRouters of the system being rolled back.

**Note:** RouterA in the registry key above is RouterB on the side B CallRouter.

- b. Verify that configuration changes are possible.

20. After the uninstallation process has completed, and both the A and B sides of your system are operating properly, set the ICM/IPCC services that were changed from their original setting of **Automatic** to **Manual** for the uninstallation back to **Automatic** to ensure that the system functions properly after a reboot.

**Note:** If you are not sure which services were changed from **Automatic** to **Manual** during the uninstallation of the Release 7.2(1), examine the setup logs located in C:\Temp\Minor Release ICM 7.2(1).

## Local Setup versus Media Setup

Running *ICMsetup.exe* from the *icm\bin* directory is referred to as *Local Setup*. Running *setup.exe* from the media is referred to as *Media Setup*. ICM Setup behaves differently when installed from the release media than it does running from the *icm\bin* directory.

**Note:** There is no concept of *Local Setup* for System IPCC. The applicable tasks performed by *Local Setup* are performed in System IPCC by the *Web Administration Tool*.

The Release 7.2(1) media can be used only to install Release 7.2(1). The Release 7.0(0) *Media Setup* is used to install new ICM components.

**Note:** If a CallRouter, Logger, AW, or WebView Server was not previously installed on a Release 7.2(1) system, these components can only be installed using Release 7.0(0) *Media Setup* after you have uninstalled all Release 7.0(0), Release 7.1(1), and Release 7.2(1) service/maintenance releases. If the CallRouter, Logger, AW, or WebView Server components previously existed, a new CallRouter, Logger, AW, or WebView Server instance can be installed using *Local Setup*.

## Local Setup Changes

Running *Local Setup* after applying Release 7.2(1) to an ICM 7.0(0) base system, or ICM 7.1(1) system allows you to:

- Add new instances (including those not previously installed)
- Add new components (even not previously installed) such as:

- PG
- Outbound Option Dialer
- MEI Server
- NAP Gateway
- Application Bridge Server
- CTI Server
- CompuCall Gateway Server
- Change the PIM type for any PG selected
- Run *Local Setup* on an AW Distributor to enable:
  - CMS
  - Agent Re-skilling WebTool
  - Internet Script Editor
  - WebView Database

You can add the above components without the need to uninstall the minor or maintenance/service releases.

## ICM Setup Rollback Support

The uninstallation of Release 7.2(1) enables a return to the previous state. For example, if the Release 7.2(1) version is applied on a system that had ICM 7.0 SR2 applied, the uninstallation of the Release 7.2(1) restores the system to the ICM 7.0 SR2 state.

An important Release 7.2(1) change is the creation of new services that depend on files added, or modified, by the Installer. *Local Setup* records the data for these services to be used by the Installer's uninstallation process to safely disable or remove these services if necessary.

If you choose to perform a temporary uninstallation of Release 7.2(1), only the services are disabled.

When Release 7.2(1) is reapplied:

- All services set to **Automatic** are changed to **Manual**.
- All new feature services disabled when the uninstallation was performed are re-enabled. Any services disabled prior to the uninstallation remain disabled.

---

**Overview**

If you perform a permanent uninstallation of Release 7.2(1) and you want all references to the components cleaned from the system, the proper approach is to delete the component for that instance. To delete a component, select it from the Instance Components list, and click **Delete**.

## Retasking a Machine

While any machine can be retasked, normally you retask an AW Distributor as a WebView server. This can only be accomplished by running Setup from the latest available media.

After Release 7.2(1) is applied, the only way a WebView server can be added to the Distributor system as a new component is by uninstalling Release 7.2(1) and all the Release 7.0 service releases to the Release 7.0 base. You can then add the WebView server using the Release 7.0 *Media Setup*. When the WebView server has been added, reapply Release 7.2(1).

In general, after Release 7.2(1) has been applied, the only way a new component (Logger, CallRouter, AW, or WebView) can be added to any ICM/IPCC system as a new component is by uninstalling Release 7.2(1), Release 7.1(1), and Release 7.0 service and maintenance releases to the Release 7.0 base. You can then add the new component using the Release 7.0 *Media Setup*. When the new component has been added, reapply Release 7.2(1).

**Note:** There is no need to reapply the 7.0 service releases as you can reapply Release 7.2(1) directly on top of Release 7.0(0). See the [Release Strategy \(page 12\)](#) section for additional information.

In general, the [Cisco ICM/IPCC Enterprise & Hosted Editions Hardware and System Software Specifications \(Bill of Materials\)](#). ([http://www.cisco.com/en/US/products/sw/custcosw/ps1001/products\\_user\\_guide\\_list.html](http://www.cisco.com/en/US/products/sw/custcosw/ps1001/products_user_guide_list.html)) for this release recommends each ICM component be installed on a separate box.

**Note:** In System IPCC, retasking a machine is accomplished using the *Web Administration Tool* by changing, within defined limits, the role of the machine.

## Schema Deployment Overview

When you invoke the Cisco ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1) Installer, it makes additions and/or modifications to the database schema. These schema modifications do not require your intervention at the time of installation.

- Status message:
  - Success:

Indicates upgrade completed successfully and provides the current database version.
  - Failure:

Indicates upgrade failed and provides error messages.

**<date>\_<time>\_Minor Release ICM7.2(1).log**

This is a date-stamped log file created each time an installation or an uninstallation is performed, logging information concerning that specific installation or uninstallation.

**Overview**

The naming convention for these separate non-concatenated logs is `<date>_<time>_Minor Release ICM7.2(1).log`, and they are created in the `<Install Drive>:\temp\Minor Release ICM7.2(1)` directory.

# Installing ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1)

---

Prior to installing ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1), ensure you take the following requirements into consideration:

- [The Baseline Requirements \(page 11\)](#) for this release.
- [Cisco ICM/IPCC Enterprise & Hosted Editions Hardware and System Software Specifications \(Bill of Materials\)](http://www.cisco.com/en/US/products/sw/custcosw/ps1001/products_user_guide_list.html) ([http://www.cisco.com/en/US/products/sw/custcosw/ps1001/products\\_user\\_guide\\_list.html](http://www.cisco.com/en/US/products/sw/custcosw/ps1001/products_user_guide_list.html))

In addition, review the [Cisco ICM/IPCC Enterprise & Hosted Editions, Release 7.2\(1\) Release Notes](http://www.cisco.com/en/US/products/sw/custcosw/ps1001/prod_release_notes_list.html) ([http://www.cisco.com/en/US/products/sw/custcosw/ps1001/prod\\_release\\_notes\\_list.html](http://www.cisco.com/en/US/products/sw/custcosw/ps1001/prod_release_notes_list.html)) and the [Release 7.2\(1\) Installation Sequence \(page 16\)](#) section.

Take the following into consideration when installing Release 7.2(1):

- A minimum of 1.2 GB of disk space is needed on the disk drive on which the ICM software is installed.
- JDK/JRE versions 1.5 or later are not supported and must be uninstalled prior to installing Release 7.2(1).
- All CallRouter, Logger, AW, and WebView systems must have Release 7.2(1) installed prior to bringing up the services.

The installation process performs the following tasks and logs the results of each step performed:

- The installation process checks the SQL Server Master database for the existence of any ICM/IPCC database.
- The installation process checks the database version of each database.

- If the schema version is below schema 95 (ICM 7.0), the process logs an error and exits.
- All other schema versions will be upgraded to version 97.

**Note:** No checks are made for the tables and columns. It is assumed that if the schema version is at the correct value then the schema is correct.

## How to install ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1)

Perform the following steps to install ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1):

---

**Step 1** Log onto your system as a user with administrative privileges.

**Step 2** After either downloading the Installer or placing the media in the drive, start the **ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1) Installer**.

The InstallShield Wizard appears; it displays the Preparing Setup dialog box.

During the next few moments the Installer determines:

- if you (the logged on user) have local administrative rights.
  - If you have administrative rights, the installation continues.
  - If you do not have administrative rights, the Installer posts an error message with instructions, then exits.
- if the correct ICM product/version is installed.
  - If the correct product/version is installed, the installation continues.
  - If the correct product/version is not installed, the Installer posts an error message with instructions, then exits.
- the service release level, if any, the product has installed.
- if Cisco Security Agent (CSA) is installed. The Installer then determines the CSA version and if the service is running.

The CSA check indicates that one of the following set of conditions exists:

- If the correct version of the CSA service (5.0 or later) is up and running, the Installer requests permission from you to stop the CSA service. If you select **Yes**, a warning message is displayed.

If you do not want the Installer to stop the service, select **No**, the Installer exits.

If you select **Yes**, the Installer stops the service and displays a status message.

**Note:** If the confirmation dialog is not displayed when attempting to stop the CSA service on a machine that has had users logged into it using a session of Remote Desktop Connection, the CSA service cannot be stopped. The Installer hangs while displaying the "Stopping CSA" dialog. Use the Windows Task Manager to disconnect and log off any users that are currently, or have previously been, connected to the system. Before attempting to stop CSA again, either allow the initial request to stop CSA to timeout (60 minutes), or reboot the system.

- If the service is running but the CSA version is not 5.0 or later, the Installer displays an error message, then exits.
- If the service is not running, and the CSA version is not 5.0 or later, the Installer displays a warning message, then provides the option to continue or not:

Select **No**. The Installer exits.

Select **Yes**. The Installer continues.

The Welcome to the InstallShield Wizard dialog box appears.

**Step 3** Click **Next**.

The License Agreement dialog box appears.


**Step 4** Select **I accept the terms of the license agreement**, then click **Next**.

If you do not accept the license agreement, the **Next** button remains disabled. You must accept the licence agreement, or you will not be able to proceed past this point.

The Select Language dialog box appears.

**Step 5** Select the appropriate language, then click **Next**.

The Installer now determines if known features were previously installed.

The Ready to Install the Program dialog box appears.

**Step 6** Click **Install** to start the installation process.

The Setup Status dialog box appears and indicates the progress of the installation. In addition to the status bar, pop-ups appear describing the actions of the Installer (for example, messages indicating when services are being stopped by the Installer).

**Note:** Shutting down services might take a while. This is normal behavior.


If an error occurs during the installation process, an Installation Errors dialog box appears providing error information. Read the errors, click **Next** and follow the on-screen instructions.

**Step 7** Enter an alpha-numeric security key of your choice for installing Support Tools.

Note: This page displays only when the Installer is running on Windows 2003 platforms.

The Installation Message dialog appears.

Figure 2: Installing Support Tools Dialog Box




**Step 8** Review the notification messages generated during the installation, then click **Next**.

The notification message in this example provides information about services being automatically changed to **Manual** as part of the installation procedure.

The 'Cisco ICM icm70 RouterA' service has been set to 'manual'. After the installation process has completed, and both A and B sides of your system are operating properly, the ICM/IPCC/SIPCC services should be set from **Manual** to **Automatic** if their original state was **Automatic**.


Here is an example of the Installation Messages dialog box:

- Step 9** Select **Yes, I want to restart my computer now** (the default), then click **Finish** to complete the setup.

After the installation process has completed, and both the A and B sides of your system are operating properly, set the ICM/IPCC services that were changed from their original setting of **Automatic** to **Manual** for the installation back to **Automatic** to ensure that the system functions properly after a reboot.

**Note:** If you are not sure which services were changed from **Automatic** to **Manual** during the installation of the Release 7.2(1), examine the setup logs located in C:\Temp\MinorRelease ICM 7.2(1).

Note: In release 7.2(1), the amount of disk space used by IPCC Enterprise CallManager PGs and IPCC System PGs has increased from approximately 300 MB to approximately 1 GB. The increased disk space usage improves performance on various sustaining activities, and does not impact production systems that follow the hardware guidelines in the ICM/IPCC Enterprise and Hosted Editions Hardware and System Software Specifications (Bill of Materials), Release 7.0(0) / 7.1(2) / 7.2(1).

However, you must consider disk space usage requirements if:

- in a laboratory environment, there is the possibility that the lab system is undersized.
- a Progger (a Central Controller and an Agent/IVR Controller System IPCC is installed on a single server) allocates too much space for the database, or
- in a multi-instance PG/hosted environment, several PGs are installed.

Assume that each CallManager PG on your platform will consume approximately 1.25 GB of disk space for trace logging. If necessary, you can modify the EMSAllLogFilesMax retention setting appropriately for the available disk space on the system.

---

## Special Setup Instructions for International Customers

To display characters correctly in ICM, traditional Chinese or Russian customers need to run a SQL utility (REBUILDM.EXE) to change the collation setting of the SQL Server on the machine where Logger or AW is installed. This step is done after ICM 7.2(1) is installed. REBUILDM.EXE is located in C:\Program Files\Microsoft SQL Server\80\Tools\Binn directory.

Traditional Chinese and Russian customers must follow the following procedure for a newly supported traditional Chinese or Russian system for ICM/IPCC Release 7.2(1):

---

- Step 1** Install SQL 2000 Server and select Latin1\_General collation with binary sort order.
- Step 2** Run the ICM/IPCC Release 7.0(0) media setup, selecting English (US) language, and then run **icm\bin\icmdba.exe** to create the Logger and AW databases. For System IPCC 7.0, run the latest **System IPCC 7.0 Installer** installer, which defaults to English (US) and creates the databases for you.

**Step 3** Install ICM/IPCC Release 7.2(1) to completion. On the language selection page, select **Chinese (traditional)** or **Russian**.

**Step 4** Back up your Logger database using **icm\bin\icmdba.exe** before performing the next step, because REBUILDM.EXE utility erases all the databases.

**Step 5** Run SQL utility **REBUILDM.EXE** and select Chinese\_Taiwan\_Stroke collation with binary sort order for traditional Chinese customers or Cyrillic\_General collation with binary sort order for Russian customers.

REBUILDM.EXE is located in C:\Program Files\Microsoft SQL Server\80\Tools\Binn directory.

**Step 6** Restore the Logger database using **icm\bin\icmdba.exe**.

## Upgrading from ICM/IPCC Release 7.0.x or 7.1.x

Customers who have installed one of the localized ICM/IPCC Release 7.0 or 7.1 can run the ICM/IPCC Release 7.2(1) Installer by selecting the same language or a different language with the exception of Traditional Chinese or Russian.

For example, if you have installed the English version of ICM/IPCC Release 7.0 on an Italian system, you can continue to select “English (US)” language during ICM/IPCC Release 7.2(1) installation. They have a chance to select “Italian” as the language during the installation. If you mistakenly select the wrong language, the problem can be corrected by running the ICM/IPCC Release 7.2(1) Installer and selecting the correct language.

If you select traditional Chinese or Russian language during the ICM/IPCC Release 7.2(1) installation, they must perform the following procedure to view agent names in their native language:

**Step 1** Back up your Logger database using **icm\bin\icmdba.exe** before performing the next step, because REBUILDM.EXE utility erases all the databases.

**Step 2** Run SQL utility **REBUILDM.EXE** and select Chinese\_Taiwan\_Stroke collation with binary sort order for traditional Chinese customers or Cyrillic\_General collation with binary sort order for Russian customers.

REBUILDM.EXE is located in C:\Program Files\Microsoft SQL Server\80\Tools\Binn directory.

**Step 3** Restore the Logger database using **icm\bin\icmdba.exe**.



## Chapter 3

# Uninstalling ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1)

---

In the event a problem occurs, you have the ability to uninstall the changes to the database schema that occurred during the installation of Cisco ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1). At the time of the uninstallation, you must decide if you wish to "return" the database schema to the previous schema version (a permanent uninstallation) or to leave the schema unmodified (a temporary uninstallation).

**Note:** Silent uninstalls are not supported.

There are two reasons to uninstall a Cisco ICM/IPCC, Release 7.2(1):

- To [temporarily uninstall \(page 36\)](#) the release to allow you to install another component from the base 7.0(0) media.

**Note:** It is never necessary to perform a temporary uninstallation on a System IPCC system as there is no concept of adding components later from the base media.

- To [permanently uninstall \(page 39\)](#) both the application and the database schema changes; returning the system to the previous service release level and returning the database to the previously installed schema version.

This is necessary if there is a failure of a major component in the release and requires the schema changes be returned to the previous schema level.

## Temporarily Uninstalling ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1)

A temporary uninstallation can be performed on any ICM/IPCC system and are performed when [retasking a system \(page 24\)](#) ICM/IPCC Hosted Editions, Release 7.2(1) is reapplied.

**Note:** A temporary uninstallation is never necessary on a System IPCC deployment. System IPCC does not require adding components using the base media.

The components requiring a temporary uninstallation of Release 7.2(1) to install are the:

- Logger (if installing on an AW)
- CallRouter (if installing on an AW or Logger)
- AW (if installing on a Logger)
- WebView (if installing on an AW or Logger)

**Note:** The Logger, AW, and HDS components check the version table in the ICM database schema for their corresponding schema version. In the event the schema version and the executable version do not match, a mis-match error message is produced and the services shut down. This error is captured in the component logs.

## How to Temporarily Uninstall Cisco ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1)

Use the Windows Add/Remove Programs utility to uninstall Cisco ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1).

### To perform a temporary uninstallation:

---

- Step 1** Log onto your system as a user with administrative privileges.
- Step 2** Select **Start > Settings > Control Panel**.  
The Control Panel dialog box appears.
- Step 3** Select **Add or Remove Programs** and then double-click.  
The Add or Remove Programs dialog box appears.
- Step 4** Select the **Cisco ICM Minor Release 7.2(1)** entry.
- Step 5** Click **Change/Remove**, then proceed as directed by the Installer.

The InstallShield Wizard opens, briefly displaying the Preparing Setup dialog box, then, if running on a machine with a database, displays the Database Schema Rollback dialog box. If not running on a machine with a database, the Setup Status dialog box appears.

During the next few moments, the Installer determines if:

- you (the logged on user) have local administrative rights.
  - If you have administrative rights, the installation continues.
  - If you do not have administrative rights, the Installer posts an error message with instructions, then exits.
- Cisco Security Agent (CSA) is installed. The Installer then determines the CSA version and if the service is running.

The CSA check indicates that one of the following set of conditions exists:

- If the correct version of the CSA service (5.0 or later) is up and running, the Installer requests permission from you to stop the CSA service. If you select **Yes**, the following message is displayed and the installation continues.

**Warning: Cisco Security Agent Service will be stopped before the Patch installation continues. It will be re-started as soon as the Patch Installation completes. Do you want to Continue?"**

If you do not want the Installer to stop the service, select **No**, the Installer exits.

If you select **Yes**, the Installer stops the service and displays a status message.

**Note:** If the confirmation dialog is not displayed when attempting to stop the CSA service on a machine that has had users logged into it via a session of Remote Desktop Connection, the CSA service cannot be stopped. The Installer hangs while displaying the "Stopping CSA" dialog. Use the Windows Task Manager to disconnect and log off any users that are currently, or have previously been, connected to the system. Before attempting to stop CSA again, either allow the initial request to stop CSA to timeout (60 minutes), or reboot the system.

- If the service is running but the CSA version is not 5.0 or later, the Installer displays an error message, then exits.
- If the service is not running, and the CSA version is not 5.0 or later, the Installer displays a warning message, then provides the option to continue or not:


If you select **No**, the Installer exits.

If you select **Yes**, the installation continues.

If so, warnings and instructions are posted indicating the required action(s).

**Step 6** Select **Temporary - The database will not be rolled back**, then click **Next**.

A confirmation dialog box appears.

**Step 7** Click **Yes**.

The Setup Status dialog box appears and indicates the progress of the temporary uninstallation.

Additional messages might appear as the temporary uninstallation proceeds.

**Note:** If an error occurs during the temporary uninstallation process, an Uninstallation Errors dialog box appears providing error information. When you have read the errors, click **Next** and follow the on-screen instructions.

When the temporary uninstallation finishes, the Uninstall Complete dialog box appears.

**Step 8** Ensure **Yes, I want to restart my computer now** is selected (the default), then click **Finish**. After the reboot, the temporary uninstallation is complete.

**Step 9** Using the ICM/IPCC Release 7.0(0) media setup, you can add the desired component to the server.

**Step 10** To reinstall ICM/IPCC Release 7.2(1) on your server, see the [Installing ICM/IPCC Enterprise & Hosted Editions, Release 7.2\(1\)](#) (page 27) section.

## Permanently Uninstalling ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1)

A permanent uninstallation is necessary if there is a failure of a major component in the release that requires the schema changes be returned to the previous schema level. This deletes all configuration data specific to the Release 7.2(1) features.

A permanent uninstallation performs the following tasks and logs the results of each step performed:

- Checks the database version
  - Performs the uninstallation of the Release 7.2(1) application, reverts the schema version to the previous ICM/IPCC schema version, logs the results, and then exits.
  - If the version is the ICM/IPCC 7.0(0) schema, the Installer logs the results, reports an error, and exits.

**Warning: Prior to performing a permanent uninstallation, perform a back up of all databases on the system.**

### How to Permanently Uninstall Cisco ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1)

Use the Windows Add/Remove Programs utility to permanently uninstall the Cisco ICM/IPCC Enterprise & Hosted Editions, Release 7.2(1).

#### To perform a permanent uninstallation:

---

- Step 1** Log onto your system as a user with administrative privileges.
- Step 2** Select **Start > Settings > Control Panel**.  
The *Control Panel* dialog box appears.
- Step 3** Double-click the **Add or Remove Programs** icon.  
The *Add or Remove Programs* dialog box appears.
- Step 4** Select the **Cisco ICM Minor Release ICM7.2(1)** entry.
- Step 5** Click **Remove**.
- Step 6** Proceed as directed by the Installer.

The InstallShield Wizard opens briefly displaying the Preparing Setup dialog box, then, if running on a machine with a database, displays the Database Schema Rollback dialog box. If not running on a machine with a database, the Setup Status dialog box appears.

During the next few moments, the Installer determines:

- if you (the logged on user) have local administrative rights.
  - If you have administrative rights, the installation continues.
  - If you do not have administrative rights, the Installer posts an error message with instructions, then exits.
- if Cisco Security Agent (CSA) is installed. The Installer then determines the CSA version and if the service is running.

The CSA check indicates that one of the following set of conditions exists:

- If the correct version of the CSA service (5.0 or later) is up and running, the Installer requests permission from you to stop the CSA service. If you select **Yes**, the following message is displayed and the installation continues.

**Warning: Cisco Security Agent Service will be stopped before the Patch installation continues. It will be re-started as soon as the Patch Installation completes. Do you want to Continue?"**

If you do not want the Installer to stop the service, select **No**, the Installer exits.

If you select **Yes**, the Installer stops the service and displays a status message.

**Note:** If the confirmation dialog is not displayed when attempting to stop the CSA service on a machine that has had users logged into it via a session of Remote Desktop Connection, the CSA service cannot be stopped. The Installer hangs while displaying the "Stopping CSA" dialog. Use the Windows Task Manager to disconnect and log off any users that are currently, or have previously been, connected to the system. Before attempting to stop CSA again, either allow the initial request to stop CSA to timeout (60 minutes), or reboot the system.


- If the service is running but the CSA version is not 5.0 or later, the Installer displays an error message, then exits.

- if features were added after the installation. If so, warnings and instructions are posted indicating the required action(s).

**Note:** Step 14 through Step 16 only appear when running an uninstallation of components with a database.

**Step 7** Select **Permanent - The database schema will be rolled back to the previous version**, then click **Next**.

The Database Schema Rollback - Confirmation dialog box appears.

**Step 8** Ensure you have backed up your database, then click **Yes - I have made a backup of the databases on this system**. A confirmation dialog box appears.

**Step 9** Select **Yes** to continue the uninstallation.

The Setup Status dialog box appears and indicates the progress of the permanent uninstallation.

Additional messages might appear as the permanent uninstallation proceeds.

**Note:** If an error occurs during the permanent uninstallation process, an Uninstallation Errors dialog box appears providing error information. When you have read the errors, click **Next** and follow the on-screen instructions.

When the permanent uninstallation is complete, the Uninstall Complete dialog box appears.


**Step 10** Ensure **Yes, I want to restart my computer now** is selected (the default), then click **Finish**. After the reboot, the permanent uninstallation is complete.

After the uninstallation process has completed, and both the A and B sides of your system are operating properly, set the ICM/IPCC services that were changed from their original setting of

**Automatic** to **Manual** for the uninstallation back to **Automatic** to ensure that the system functions properly after a reboot.

**Note:** If you are not sure which services were changed from **Automatic** to **Manual** during the installation of the Release 7.2(1), you can examine the setup logs located in C:\Temp\MinorRelease ICM 7.2(1).

Note: Uninstalling the Support Tools 2.1 Node is an *optional* procedure. To uninstall the Support Tools 2.1 Node:

1. Log onto your system as a user with administrative privileges.
  2. Select **Start > Settings > Control Panel**. The Control Panel dialog box appears.
  3. Double-click the **Add or Remove Programs** icon. The Add or Remove Programs dialog box appears.
  4. Select the **Cisco Support Tools 2.1 Node** entry.
  5. Click **Change/Remove**.
  6. The InstallShield Wizard opens briefly displaying the Preparing Setup dialog box.
  7. A Question dialog box opens and asks if you wish to proceed.
  8. Select **Yes** if you wish to continue with the uninstall process.
  9. At this point, the uninstall process starts uninstalling the Cisco Support Tools 2.1 Node application.
  10. Click **Finish** when the Maintenance Complete dialog box appears.
  11. The Cisco Support Tools 2.1 Node has been uninstalled, and you are now returned to the Add or Remove Programs utility.

## Chapter 4

# Silent Installation and Manual Recovery from Installer Failures

---

## Silent Installations

Installation programs developed with InstallShield platforms have a mechanism for running the Installer in a silent mode. In a silent installation, interactive dialogs are not displayed. Information and answers that you would normally provide are read from a response file. Response files can be identified by having the same name as the Installer executable file, but with an “.iss” extension.

Response files are created by first running the installer in “record mode”. During record mode, you manually enter information the same way as if the product would be used in normal mode. To enter record mode, start the setup program from a command prompt and pass in a `/r` command line parameter. For example, if the setup program executable is `setup.exe`, then a response file `setup.iss` is created when the Installer is launched using the command `setup.exe /r`. When the response file is created, another installation can be performed launching the Installer with the command: `setup.exe /s`.

**Warning: Silent installations can be dangerous when performed with incorrect response files, and their use is discouraged. If you choose to use this method, be absolutely certain that the execution environment is configured identically to the environment where the response file was created. Slight variations in the configuration can cause unexpected errors or different installation paths that does not align with the expected response file structure. These situations could lead to a catastrophic failure of the Installer program, which, in turn, would require a manual recovery.**

### General Rules of Thumb for Silent Installations

- CSA must be stopped prior to creating the response file, and prior to running the installer silently.
- When running an installation silently, the system configuration must match as close as possible to the system which the response file was created on. The idea here is to minimize the potential for any unexpected dialogs during the install process. For example if the response file is created on a machine where the ICM services are set to **Manual** and then run on a machine who's ICM services are set to **Automatic**, the installation process displays an additional dialog alerting you that the services have been set from **Automatic** to **Manual**. Since the response file was created on a machine whose services were already set to **Manual**, it is not expecting this dialog, which causes the installation to terminate abruptly and leave the system in an invalid state requiring a manual recovery.
- If, during the creation of the response file, you choose not to reboot the machine after the install completes, remember to manually reboot any silently installed system prior to starting the services.
- Always verify that the Installer log matches the expected results. An incomplete installation can have serious negative consequences if not properly identified.

Running a silent installation for the 7.2(1) ICM/IPCC Enterprise and Hosted Editions is a two step process:

- First, create a response file by running setup from a command prompt with two command line arguments.

An example of the correct syntax is: `C:\>ICM7[2].1(1)_72_build_17347-Release.exe -r -f1c:\myanswerfilename.iss`

The `-r` flag is for recording the response file.

The `-f1` flag is the full path and filename for the resulting response file to be saved in.

**Note:** There is no space between the `-f1` and the start of the file path. If no `-f1` flag is present, the response file is written to a default location.

When you have stepped through all of the setup process (which completes a full installation the product on the machine recording the response file) the resulting response file can be copied to any additional machine to be used during a silent installation.

- Invoke a silent installation by running setup from a command prompt with the same syntax as above, with the following exception: use `-s` instead of `-r` to indicate the installation runs silently using the response file found at `-f1filepath` ( Example: `C:\>ICM7[2].1(1)_72_build_17347-Release.exe -s -f1c:\myanswerfilename.iss`).

Verify that the silent installation completed successfully by checking the Installer log file to make sure no errors were reported, and that the Installer ran to completion.

Refer to [HOW TO: Create a Silent Installation](http://support.installshield.com/kb/view.asp?articleid=Q101901) (<http://support.installshield.com/kb/view.asp?articleid=Q101901>) (MacroVision Knowledge Base document ID: Q101901) for detailed information on how to create a silent installation.

## Recovering from Failures of the Installer

There are situations where the Installer might fail for reasons that cannot be anticipated or controlled.

Possible failure scenarios:

- The system experiences a loss in power.
- The system might lock up due to the failure of another process.
- The virtual machine hangs or is accidentally shut down.
- Using an incorrect or incomplete response file for silent installs.
- The installer completes successfully, but for some unknown reason you are unable to un-install using **Add/Remove Programs** in the Control Panel.

Under "normal" conditions, when a failure in an InstallShield program occurs, the Installer can be aborted. An abort event is processed by InstallShield and the setup program attempts to undo the changes it has made. Changes include file deployments, registry modifications, and other modifications to Windows shell objects.

The InstallShield engine does not include native capabilities for either file backup during install or file return during uninstallation. These additional tasks are scripted enhancements made to the Windows based installer. If there is a catastrophic failure during the installation (or any other state that blocks the uninstaller program from running) the file return needs to be performed manually.

**Warning: Do not attempt to repair a system by only modifying the registry and running the installation a second time. This causes you to lose the ability to return the system back to its pre-installation state. If the Installer is run a second time, it backs up the recently installed versions of files, overwriting the original files previously copied to the backup directories.**

The manual recovery steps outlined below are performing a "Temporary" uninstallation. This means that files are being restored to their pre-installation (Release 7.0(0)) state, but the previous database schema is not restored. In the event of a major failure, it might not be easy to determine whether or not the proper files are in place to rollback the schema. By following the procedures listed below the system can be returned to a known state from which the Installer can be reapplied.

Backup files are stored in directories that are immediate children of the original file location. The directory name is the minor release version number with each numerical component separated by an underscore, as in ICM\_7\_2\_1\_0\_0\_0\_44. For example, files patched in the C:\icm\bin

directory are copied to a directory with a name that resembles this pattern:

C:\icm\bin\\_ICM\_7\_2\_1\_0\_0\_0\_44.

A list is kept in a text file for every backup directory created. This file is written to the product root directory (example: C:\icm\\_ICM\_7\_2\_1\_0\_0\_0\_44\Return\_ICM\_7\_2\_1\_0\_0\_0\_44.txt).

## How to Manually Return a Failed Release 7.2(1) Installation to the Pre-installation State

Perform the following steps to manually return a failed Release 7.2(1) installation:

**Note:** This process must be followed only if the Add/Remove Programs uninstallation procedure fails.

- 
- Step 1** Locate all the backup directories using the return list file.
- Step 2** Copy all of the files in each backup directory to its immediate parent directory.
- Step 3** Delete the backup directories and all their contents.

**Note:** While the deletion of the backup directories is functionally optional, it helps to keep the system clean. In the event you do delete the backup files here, it might be worthwhile to store them in a safe location elsewhere.

- Step 4** Clean up the registry by removing the Installer information.

For example, the Installer information for ICM\_7\_2\_1\_0\_0\_0\_44 is removed by deleting this key and all its contents (HKLM\SOFTWARE\Cisco Systems, Inc.\Patch\ICM\7.0\Patch\ICM\_7\_2\_1\_0\_0\_0\_44).

- Step 5** If a new language selection was made during the install, the language selection must also be reset by modifying registry named values under the key HKLM\SOFTWARE\Cisco Systems, Inc.\ICM\SystemSettings.
- Copy the value of "Last Language" to "Language".
  - Copy the value of "Last LanguageAbbrev" to "LanguageAbbrev".

---

While the previous instructions restores most ICM nodes, more needs to be done for a WebView deployment. WebView places many additional requirements on the Installer, such as copying files from a base repository to each WebView instance, updating templates, cleaning out caches, etc. There is no easy way to manually recover the WebView changes. However, if the manual recovery previously described is followed, the Installer might be safely applied again, and recover the WebView deployment. When a successful installation of this minor release is deployed, the uninstallation program can be run normally to restore the WebView state to pre-installation configuration.
